**SUBJECT: VISION SESSION OF THE TOWN COMMISSION
WEDNESDAY, JANUARY 4, 2012 AT 6:00 P.M. AT THE TOWN HALL**

THE VISION SESSION IS MEANT TO BE AN "OVERVIEW," GIVING EACH COMMISSIONER AS WELL AS THE TOWN MANAGER AN OPPORTUNITY TO SPEAK OF HIS OR HER WISHES FOR THE TOWN AND FOR THE COMMISSION IN AN OPEN AND SUPPORTIVE ENVIRONMENT.

EACH MEMBER WILL HAVE TEN MINUTES TO PRESENT HIS OR HER WISHES AND IDEAS, FREE OF COMMENT FROM OTHER COMMISSIONERS. HAND OUTS ARE ALLOWED. WITH EACH MEMBER HAVING UP TO TEN MINUTES TO PRESENT, ONE HOUR WILL HAVE PASSED AFTER EVERYONE HAS SPOKEN. ONLY AFTER EVERYONE HAS PRESENTED, WILL QUESTIONS BE ENCOURAGED AND DISCUSSION ENGAGED.

IF AFTER FORTY-FIVE MINUTES OF DISCUSSION LED BY THE MAYOR, THE COMMISSIONERS ARE COMFORTABLE, THEY WILL BE ASKED TO RANK THE WISHES OF EACH COMMISSIONER IN LIGHT OF COST AND CIRCUMSTANCE TO DETERMINE IF AND HOW THESE GOALS CAN BE ACHIEVED. IF THEY CANNOT, AT LEAST EACH COMMISSIONER HAS BEEN ABLE TO SHARE WHAT IS IMPORTANT TO THEM, COMMISSIONERS WILL KNOW EACH OTHER BETTER, AND HOPEFULLY THESE GOALS CAN BE ADDRESSED ONCE AGAIN IN THE FUTURE. NONETHELESS, THE GOAL IS TO WALK AWAY BEING ABLE TO SUPPORT SOME IDEA OF EACH COMMISSIONER.
