DISCUSSION

1. Special Exception Application to Permit a Structure at 163 South Sewall's Point Road

Town Manager Walker presented the item to the Commissioners. There was discussion among the Commissioners, Town Manager and Town Engineer.

Motion was made by Vice Mayor Fender seconded by Commissioner Campo to approve the Special Exception application; it was voted as follows: Ayes: Mayor Luger, Vice Mayor Fender, Commissioners Barile, Campo and Morris. Motion passed unanimously.

2. Modification of Unity of Title for 160 & 163 South Sewall's Point Road Town Manager Walker presented the item to the Commissioners.

Motion was made by Commissioner Campo seconded by Vice Mayor Fender to approve the Unity of Title Modification for 160 & 183 South Sewall's Point Road; it was voted as follows: Ayes: Mayor Luger, Vice Mayor Fender, Commissioners Barile, Campo and Morris. Motion was passed unanimously.

3. Purchase and Sale Agreement for Stormwater Treatment Pond required for South Sewall's Point Road Phase I Project

Town Manager Walker presented the item to the Commissioners. There was discussion among the Commissioners.

Motion was made by Commissioner Campo seconded by Vice Mayor Fender to approve the Purchase and Sale Agreement for Stormwater Treatment Pond required for South Sewall's Point Road Phase 1 Project; it was voted as follows: Ayes: Mayor Luger, Vice Mayor Fender, Commissioners Campo and Morris. Nay: Commissioner Barile. Motion passed 4-1.

Town Manager Walker presented the new town maps to the Town Commissioners.

Town Clerk Burch asked the Commissioners their thoughts on continuing to print full agendas for the public due to the cost of the Town. Town Commissioners came to the consensus for this to be discussed at a workshop if direction was needed from them.
