ORDINANCE NO. 166

AN ORDINANCE OF THE TOWN SEWALL'S POINT, FLORIDA, AMENDING SECTION 4-16(a) OF THE CODE OF ORDINANCES OF THE TOWN OF SEWALL'S POINT; ADOPTING THE SOUTH FLORIDA BUILDING CODE IN ITS MOST RECENT EDITION AND REVISIONS AS THE BUILDING CODE FOR THE TOWN OF SEWALL'S POINT; PROVIDING FOR INSERTION INTO THE TOWN CODE; PROVIDING REPEAL OF ORDINANCES AND RESOLUTIONS IN CONFLICT THEREWITH; PROVIDING FOR SEPARATION IN THE EVENT A SECTION OR PORTION IS DECLARED TO BE UNCONSTITUTIONAL, PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Commission for the Town of Sewall's Point has determined that the following ordinance is a necessary and proper exercise of the town's authority.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, as follows:

That Section 4-16(a) of the Town of Sewall's Point Code of Ordinances is hereby amended to read as follows:

- (a) There is hereby adopted as a building code for the Town, by reference as fully and to the extent as though set out at length herein, to the extent conflicting with other ordinances and resolutions of the Town, that certain published code known as "The South Florida Building Code," in the most recent edition and most recent revisions thereto on file from time to time in the office of the Town building inspector.
- (a) The town hereby adopts as a building code for the town the South Florida Building Code, 1975 Edition, which is herewith made a part hereof as fully as if herewith completely incorporated, and all appendices thereto and hereto attached, said code being further identified as being copyrighted by the Board of County Commissioners of Dade County, Florida, and having been originally adopted by the Board of County Commissioners of Dade County on October 29, 1957, except as otherwise provided in this chapter.

SEPARATION.

If any section, sentence, clause, phrase or word of this Ordinance is for any reason held or declared to be unconstitutional, inoperative or void, such holding or invalidity shall not affect the remaining portions of this Ordinance, and it shall be construed to have been the intent of the Board to adopt this Ordinance without such unconstitutional, invalid or inoperative part therein, and the remainder of this Ordinance after the exclusion of such part or parts, shall be deemed and held to be valid as if such part or parts had not been included herein. If this Ordinance or any provision thereof shall be held to be inapplicable to any person, groups of persons, property, kind of property, circumstances or set of circumstances, such holdings shall not affect its applicability to any other person, property or circumstances.

REPEAL.

Town ordinances and Town resolutions, or parts thereof, in conflict with this Ordinance are hereby abolished and repealed to the extent of such conflict.

INCORPORATION IN TOWN CODE.

Provisions of this Ordinance shall be incorporated in the Town Code and the word "Ordinance" may be changed to "section," "article," or other appropriate word, and the sections of this Ordinance may be renumbered or relettered to accomplish such intention.

EFFECTIVE DATE.

This Ordinance shall become effective immediately upon the date of its passage according to law.
