

RESOLUTION NO. 39

A RESOLUTION RELATING TO THE OVERPAYMENT OF ROAD AND BRIDGE FUNDS BY MARTIN COUNTY FLORIDA TO THE TOWN OF SEWALLS POINT FLORIDA AND PROVIDING FOR REFUNDING THE EXCESS AMOUNTS.

WHEREAS the Certificated Public Accountant employed by the Board of Commissioners of Martin County, Florida has discovered the errors made in compiling the assessed valuation of the Town of Sewalls Point has resulted in the overpayment of the Road and Bridge Tax refund to the Town of Sewalls Point as follows:
