

RESOLUTION No. 88

RESOLUTION OF THE TOWN OF SEWALL'S POINT, FLORIDA, PERTAINING TO THE ADOPTION OF A PLAN FOR NUMBERING THE DWELLINGS LOCATED WITHIN THE TOWN AND PROVIDING THAT THE NUMBERS OF THE RESPECTIVE PARCELS OF PROPERTY BE KEPT IN THE CITY HALL AND ASSIGNED TO THE RESPECTIVE PROPERTY OWNERS UPON THEIR APPLICATION.

WHEREAS, the Town of Sewall's Point has been without a street numbering system, and

WHEREAS, it has been most inconvenient for non-residents, trade people and others seeking to locate homes and dwellings on Sewall's Point because of no street numbers, and

WHEREAS, the Town needs a plan of numbering, and

WHEREAS, one of the citizens of the Town of Sewall's Point, Mr Samuel Nexsen, did, without remuneration, work up a plan of numbers, and

WHEREAS, this plan is acceptable to the Town, and

WHEREAS, the Town Commission believes it is for the best interest that this numbering system be adopted,

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN OF SEWALL'S POINT, FLORIDA:

1. That the numbering system as prepared by Mr Samuel Nexsen, be, and the same is hereby adopted by the Town as an official numbering system.
