

RESOLUTION NO. 202

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, ACCEPTING THE RESIGNATION OF POLICE OFFICER BARBARA BLACK.

WHEREAS, Police Officer Barbara Black submitted her written resignation from the Police Department of the Town of Sewall's Point on March 16, 1983, to be effective April 15, 1983; and

WHEREAS, the Mayor of the Town of Sewall's Point accepted Officer Black's resignation, subject to approval of the Town Commission at its regular April 1983 meeting and relieved Officer Black of official duties with pay pending review and approval of her resignation by the Town Commission; and

WHEREAS, the Town Commission wishes to accept Officer Black's resignation and approve and adopt the action of the Mayor.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA:

1. The resignation of Officer Barbara Black dated March 16, 1983, a copy of which is attached to this resolution, is hereby accepted by the Town of Sewall's Point, Florida.
2. The action of the Mayor of the Town of Sewall's Point, Florida, in removing Officer Barbara Black from active duty with pay pending acceptance of her resignation by the Town Commission is hereby approved and adopted.
3. The Chief of the Town of Sewall's Point Police Department is hereby directed to obtain all Town property from Officer Barbara Black on or before April 15, 1983, and to notify the Criminal Justice Standards and Training Commission of Officer Black's termination of employment by reason of her resignation, in accordance with Section 943.23, Florida Statutes.

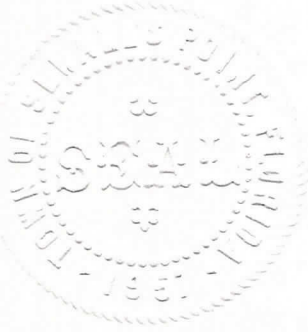




