

RESOLUTION NO. 220

A RESOLUTION OF THE TOWN OF SEWALL'S POINT, FLORIDA, COMMENDING AND THANKING COMMISSIONER EDWARD H. GLUCKLER FOR SERVICES RENDERED BY HIM TO THE TOWN OF SEWALL'S POINT.

WHEREAS, on March 2, 1976, EDWARD H. GLUCKLER was elected to the Town Commission by the voters of the Town of Sewall's Point, and

WHEREAS, EDWARD H. GLUCKLER devoted many hours to and in the performance of his duties as Mayor, Commissioner and Liaison with Public Utilities for the Town and did so in an exemplary and outstanding manner, and

WHEREAS, the Town Commission of the Town of Sewall's Point has unanimously voted to commend EDWARD H. GLUCKLER for the services performed and rendered by him on behalf of the Town of Sewall's Point and its citizenry.
