

RESOLUTION NO. 256

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT SETTING FORTH THE PROCEDURE FOR ACCEPTANCE AND REVIEW OF REQUESTS FROM RESIDENTS FOR THE INSTALLATION OF STREET LIGHTING AND THE NECESSARY APPURTENANCES.

WHEREAS, Town residents periodically make requests to the Town Commission that street lighting facilities be installed in certain areas of the Town; and

WHEREAS, no established procedure exists for the acceptance, processing, and review of said requests; and

WHEREAS, consideration of such requests necessarily involves consultation and coordination with Florida Power & Light Company; and

WHEREAS, the Town Commission has deemed it necessary and beneficial to establish a uniform procedure for the processing and evaluation of such requests.

NOW THEREFORE BE IT RESOLVED by the Town Commission of the Town of Sewall's Point, Florida that the following procedure is hereby adopted:

1. All requests for the installation of new street lighting facilities within the Town shall be made by written petition signed by a majority of the property owners in the affected area, which shall be filed with the Town Clerk.

2. Within sixty (60) days after filing of the petition with the Town Clerk, the Town Commission shall consider the petition and make a determination regarding the need and desirability of street lighting in the affected area.

3. If a majority of the Town Commission deems it desirable to proceed with a study of the lighting needs asserted in the petition, a written notice shall be directed to Florida Power & Light Company requesting that it assign a competent lighting engineer to study the area under consideration in consultation with representatives of the Town and the Petitioners, to be designated by the Commission.

4. The study shall consider and evaluate such factors as optimum lighting, cost effectiveness, and on-going maintenance, and

shall be submitted to the Town Commission upon completion.

5. If the Town Commission, after considering the results of the study and any other relevant information, approves the petition for lighting, Florida Power & Light shall be directed to install concrete poles and standard lighting fixtures.

6. Monthly charges for service and facility rental for the new installation shall thereafter be paid by the Town to Florida Power & Light Company according to its schedule of rates and charges in effect from time to time.
