

RESOLUTION 258

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, APPOINTING WILLIAM D. CONNOLLY AND WILLIAM J. FIELDS AS REGULAR MEMBERS AND APPOINTING DOLORES M. CLARKE AND DOUGLAS WULFFLEFF AS ALTERNATE MEMBERS OF THE BOARD OF ZONING ADJUSTMENT.

WHEREAS, the term of ELEANOR EASON on the Town of Sewall's point Board of Zoning Adjustment has expired; and

WHEREAS, D. W. GRAHAM has resigned from his term on the Town of Sewall's Point Board of Zoning Adjustment; and

WHEREAS, the Town Commission wishes to fill the resulting vacancies by redesignating WILLIAM D. CONNOLLY and HAMILTON W. STILES from alternate members to regular members and by appointing DOLORES M. CLARKE and DOUGLAS WULFFLEFF as alternate members of the Board of Zoning Adjustment.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA:

1. That WILLIAM D. CONNOLLY and HAMILTON W. STILES shall serve as regular members of the Board of Zoning Adjustment of the Town of Sewall's Point, Florida, from February 5, 1986, through the expiration of their current terms.

2. That DOLORES M. CLARKE is hereby appointed to serve as an alternate member of the Board of Zoning Adjustment of the Town of Sewall's Point, Florida, from the date of filing her oath of office through the date of the regular meeting of the Town Commission in February 1989.

3. That DOUGLAS WULFFLEFF is hereby appointed to serve as an alternate member of the Board of Zoning Adjustment during the remaining term of D. W. GRAHAM from the date of filing his oath of office through the date of the regular meeting of the Town Commission in May 1987.
