A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, APPROVING AND AUTHORIZING INTERLOCAL AGREEMENT WITH MARTIN COUNTY FOR COLLECTION OF ROAD IMPACT FEES.

WHEREAS, Martin County is in the process of adopting a road impact fee ordinance which it wishes to be effected and collected in the Town of Sewall's Point; and

WHEREAS, Martin County wishes for the Town of Sewall's Point to collect the road impact fee as an agent of Martin County; and

WHEREAS, the Town Attorney has prepared and the Town Commission has reviewed a form of Interlocal Agreement for the collection of road impact fees between Martin County and the Town of Sewall's Point, and the Town Commission has determined that is acceptable to them.

- The form of the Interlocal Agreement between Martin County and the Town of Sewall's Point presented to the meeting of the Town Commission on September 10, 1986, is approved.
- That the Mayor of the Town of Sewalls Point is authorized to sign the Interlocal Agreement and the Town Attorney is authorized to forward the signed Interlocal Agreement to Martin County.


