RESOLUTION NO. 284

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, REPEALING RESOLUTION NO. 199 AND PROHIBITING PARKING IN THE TOWN HALL PARKING LOT, EXCEPT FOR TOWN BUSINESS.

WHEREAS, on September 15, 1982, the Town Commission of the Town of Sewall's Point adopted Resolution No. 199 authorizing parking of certain motor vehicles, boats and hauling trailers in the Town Hall parking lot for limited periods upon registration with the Town Police Department; and

WHEREAS, in connection with construction of the new Town Hall, the Town Commission has determined that the continued use of the Town Hall parking lot for storage purposes may cause inadequate parking to be available for persons with business at the Town Hall;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA:

- 1. That Resolution No. 199 is hereby repealed.
- That parking in the Town Hall parking lot shall be limited to temporary parking of motor vehicles while the driver or a passenger is within the Town Hall or attending to matters involving the Town.
- 3. That the Police Chief of the Town of Sewall's Point shall cause the following sign to be conspicuously posted within the parking lot at Town Hall:

RESTRICTED PARKING

This lot is reserved for the parking of motor vehicles while the driver or passenger is within the Town Hall or attending to matters involving the Town.

RESOLUTION NO. 199 A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, AUTHORIZING PARKING OF CERTAIN MOTOR VEHICLES, BOATS AND HAULING TRAILERS IN THE TOWN HALL PARKING LOT FOR LIMITED PERIODS UPON REGISTRATION WITH THE TOWN POLICE DEPARTMENT WHEREAS, on December 12, 1979, the Town of Sewall's Point adopted the Town of Sewall's Point Parking Ordinance, Section XI-A, Code of Ordinances, Town of Sewall's Point, Florida, which prohibits unconcealed parking of certain motor vehicles, boats and hauling trailers; and WHEREAS, the Town Commission, as a convenience to the residents of the Town and their guests, wishes to provide for temporary parking of such vehicles, boats and hauling trailers within the parking lot at the Town Hall upon proper registration with the Police Department of the Town of Sewall's Point; and WHEREAS, the Town Commission wishes to provide for removal of such vehicles, boats and hauling trailers that are not registered or that are not removed from the Town Hall parking lot within the permitted period; and WHEREAS, it is not intended that the Town act as bailee or custodian or assume any obligations with regard to such motor vehicles, boats and hauling trailers; NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA: 1. Residents and owners of real property within the Town of Sewall's Point and their guests shall be permitted to park motor vehicles, boats and hauling trailers otherwise required to be totally concealed from view under the provisions of the Town of Sewall's Point Parking Ordinance, Section XI-A, Code of Ordinances, Town of Sewall's Point, Florida, within the parking lot of the Town Hall for a period not exceeding fourteen (14) days upon proper registration with the Police Department as provided herein. Before parking any such motor vehicle, boat or hauling trailer in the parking lot at the Town Hall, the owner or person in lawful possession shall register with the Police Department of the Town of Sewall's Point by completing and signing the Parking Registration form attached to this resolution.

- No such motor vehicle, boat or hauling trailer shall be registered more frequently than once every forty-five (45) days.
- Any such motor vehicle, boat or hauling trailer that is left in the parking lot at the Town Hall without being properly registered, or any such motor vehicle, boat or hauling trailer that is left in the parking lot at the Town Hall after proper registration for a period exceeding fourteen (14) days, shall be removed and towed away by the Town of Sewall's Point Police Department or shall be caused to be removed and towed away by a commercial towing service, to be stored in a safe place and restored to the owner or registrant upon payment of the towing fee, together with any costs incurred for storage.
- The Police Chief of the Town of Sewall's Point shall cause the following sign to be conspicuously posted within the parking lot at the Town Hall:

RESTRICTED PARKING

Any vehicle, boat or trailer parked in this lot for other than Town business without being REGISTERED with the Town of Sewall's Point Police Department shall be TOWED AWAY at the owner's expense.

This resolution shall not be construed to prohibit the temporary parking of any type of motor vehicle in the Town Hall ' parking lot while the driver or a passenger is within the Town Hall or attending to matters involving the Town, nor shall this resolution be construed to allow temporary parking or storage of any type of motor vehicle in the Town Hall parking lot when the driver or a passenger is not within the Town Hall or attending to matters involving the Town except as provided herein.
