

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, COMMENDING AND THANKING COMMISSIONER CLIFFORD B. DRAKE FOR SERVICES RENDERED BY HIM TO THE TOWN OF SEWALL'S POINT.

WHEREAS, after serving for many years as the Chairman of the Code Enforcement Board of the Town of Sewall's Point, Florida, on August 10, 1983, CLIFFORD B. DRAKE was elected to serve as Town Commissioner by the Board of Commissioners of the Town of Sewall's Point, Florida; and

WHEREAS, in March, 1986, CLIFFORD B. DRAKE was re-elected to the Town Commission, receiving the highest number of votes from the voters of the Town of Sewall's Point; and

WHEREAS, CLIFFORD B. DRAKE was duly appointed by the Town Commission to serve as Director of Law Enforcement, Fire Protection and Roads for the Town of Sewall's Point; and

WHEREAS, CLIFFORD B. DRAKE has supported and guided the establishment of a new Town Hall for the Town of Sewall's Point, and the acquisition and construction of additional sections of South River Road, and the organization of the Police Department of the Town of Sewall's Point, as well as performing other duties for the Town of Sewall's Point; and

WHEREAS, CLIFFORD B. DRAKE has devoted many hours to and in the performance of his duties as Town Commissioner and as Chairman of the Code Enforcement Board, and he did so in an exemplary and outstanding manner; and

WHEREAS, CLIFFORD B. DRAKE has submitted his resignation as Commissioner of the Town of Sewall's Point; and

WHEREAS, the Town Commission of the Town of Sewall's Point has unanimously voted to commend CLIFFORD B. DRAKE for the services performed and rendered by him on behalf of the Town of Sewall's Point and its citizenry.

NOW, THEREFORE, BE IT RESOLVED THAT THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, hereby commends and honors its citizen and Commissioner, CLIFFORD B.
