[REGARDING THE REQUEST OF MARTIN COUNTY TO THE U.S. COAST GUARD TO ESTABLISH DRAWBRIDGE OPERATION REGULATIONS FOR FOUR (4)
BRIDGES IN THE URBANIZED AREA OF MARTIN COUNTY]

WHEREAS, the Board of County Commissioners of Martin County has received a request from the Local Planning Agency of Martin County to establish regulations controlling the operation of four (4) drawbridges in the urbanized area of the County; and

whereas, the Local Planning Agency discussed the benefits of regulated bridge openings with the residents of Martin County on July 17 and August 7, 1986; and

WHEREAS, the Recreational Boating Advisory Committee also considered the benefits of regulated bridge openings and found that certain restrictions on bridge openings would be acceptable to the boating community.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MARTIN COUNTY THAT:

Martin County requests that the Commander, Seventh Coast Guard
District, establish the following specific regulations to control the openings
of the following bridges to boating traffic:

- Affected bridges include the Frank Wacha, Sr., Bridge (Jensen Beach Causeway), Ernest Lyons Bridge (Stuart Causeway), the Evans Crary Bridge and the Roosevelt Bridge.
- 2. Opening regulations be imposed from December 1st to May 1st each year for all bridges except the Roosevelt, which should be regulated thoughout the year.
- 3. Restrictions on all bridges would extend from 6:00 A.M. to 6:00 P.M. each day except Saturdays, Sundays, and Holidays.
- 4. All four (4) bridges to open on the hour and half hour during the 6:00 A.M. to 6:00 P.M. period.
- 5. The Roosevelt Bridge, additionally, would remain closed to boating traffic for 1 1/2 hours during the two (2) peak traffic periods, specifically, the Roosevelt Bridge will not open at 8:00 a.m. and 8:30 a.m. and at 5:00 and 5:30 p.m.

7. During time of no restriction, bridges will remain closed for 15 minutes minimum after any opening.
