A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, AUTHORIZING AND APPROVING CONSTRUCTION OF A SWIMMING POOL FOR RICHARD C. MARTIN AND GEORGIANN MARTIN, AS JOINT TENANTS.

LEGAL DESCRIPTION

All of Lot 79 of ISLE ADDITION TO HIGH POINT according to the Plat thereof as recorded in Plat Book 4, Page 47, Official Records of Martin County, Florida, more particularly described in the Map of Survey attached hereto and made a part hereof.

WHEREAS, the Town Commission of the Town of Sewall's Pont has authority under the Code of Ordinances of the Town of Sewall's Point, Appendix B - ZONING, Section XI. E. No. 2, to grant permission for lot owners to construct swimming pools within fifty (50) feet of the natural high water mark on waterfront lots, and

WHERAS, RICHARD C. MARTIN and GEORGIANN MARTIN, as joint tenants, have applied for permission and a permit for construction of a swimming pool to be located within fifty (50) feet of the natural high water mark on the property, and

WHEREAS, the Town Commission has reviewed the application for the permit by RICHARD C. MARTIN and GEORGIANN MARTIN, as joint tenants, and have determined that it meets all other criteria and requirements of the Code of Ordinances of the Town of Sewall's Point.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, that:

- 1. RICHARD C. MARTIN and GEORGIANN MARTIN, as joint tenants are hereby granted approval of the Town Commission of the Town of Sewall's Point to construct a swimming pool on the above-described waterfront lot in accordance with plans submitted to the Building Department of the Town of Sewall's Point, a portion of which is attached hereto.
- 2. This approval shall be for the construction of a swimming pool only and shall not constitute permission or license, either now or in the future, to enclose the swimming pool hereby approved with a screen enclosure or other type of enclosure.
