A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, APPROVING THE AWARD OF THE BID FOR CONTINUING SERVICES FOR MAINTENANCE SERVICES RELATIVE TO ROADWAY/PARKING/STORMWATER IMPROVEMENTS; APPROVING THE AWARD OF THE BID FOR DISASTER RECOVERY – FIRST 72 HOURS (EMERGENCY); APPROVING THE AWARD OF THE BID FOR DISASTER RECOVERY – VEGETATIVE AND STORM DEBRIS REMOVAL; APPROVING THE AWARD OF THE BID FOR MICROSURFACING/CRACK SEALANT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Sewall's Point, Florida is a duly constituted municipality having such power and authority conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and

WHEREAS, it is necessary for the Town to obtain the following services: maintenance services relative to roadway/parking/stormwater improvements; disaster recovery – first 72 hours (emergency); disaster recovery – vegetative and storm debris removal; and micro-surfacing/crack sealant; and

WHEREAS, the Town issued invitations to bid for each of the above services' and WHEREAS, the Town wishes to award each of the bids as set forth in the recommendations (attached hereto as Exhibit "A") made by the Town of Sewall's Point Engineer, Joseph W. Capra, P.E.; and

WHEREAS, the Town has determined that awarding each of the bids in accordance with the Town Engineer's recommendations is in the best interest of the health, safety, and welfare of its respective residents.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA:
