

**RESOLUTION NO. 815**

**A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, ADOPTING THE TENTATIVE MILLAGE RATE FOR THE TOWN OF SEWALL'S POINT FOR THE FISCAL YEAR COMMENCING ON OCTOBER 1, 2015 AND ENDING ON SEPTEMBER 30, 2016; AND PROVIDING FOR AN EFFECTIVE DATE AND OTHER PURPOSES.**

**WHEREAS**, the Town of Sewall's Point, Florida (hereinafter, "Town") is a duly constituted municipality having such power and authority conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and

**WHEREAS**, the Town has this date held a properly advertised public hearing pursuant to the requirements of 200.065, Florida Statutes, to adopt a tentative millage rate for the 2015-2016 fiscal year; and

**WHEREAS**, it is the will and desire of the Town Commission that the tentative millage rate be approved and adopted as set forth below.

**NOW THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA:**

**Section 1.** The whereas clauses are incorporated herein as true and correct and as the legislative findings of the Town Commission.

**Section 2.** The Town Commission of the Town of Sewall's Point does hereby adopt its tentative operating millage rate of 2.87 mills to be levied for the General Fund upon all real and tangible personal property located with the boundaries of the above named taxing authority.

**Section 3.** The FY 2015-2016 operating millage rate of 2.87 mills is greater than the rolled-back rate of 2.54 mills by 0.33%.

**Section 6.** This resolution will take effect immediately upon its adoption.

*Commissioner Thurlow-Lippisch* offered the Resolution and moved its adoption. The motion was seconded by


