

**RESOLUTION NO. 829**

**A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, SUPPORTING THE FORMATION OF THE INDIAN RIVER LAGOON COMPACT; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Sewall's Point supports participation in the Indian River Lagoon Regional Compact, which does not require any financial commitment from the Town; and

**WHEREAS**, the Town of Sewall's Point supports the formulation of the Indian River Lagoon Regional Compact and shares the common belief that our quality of life along the Indian River is dependent upon the environmental and economic vitality of the Lagoon.

**NOW THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA:**

**Section 1.** That whereas clauses are incorporated herein as true and correct and as the legislative findings of the Town Commission.

**Section 2.** The Town Clerk is forward a copy of this resolution to the appropriate parties, indicating that by its adoption the Town of Sewall's Point supports the formation of the Indian River Lagoon Compact.

**Section 3.** This resolution will take effect immediately upon its adoption.
