RESOLUTION NO. 833

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, ADOPTING THE TENTATIVE MILLAGE RATE FOR THE TOWN OF SEWALL'S POINT FOR THE FISCAL YEAR COMMENCING ON OCTOBER 1, 2016 AND ENDING ON SEPTEMBER 30, 2017; AND PROVIDING FOR AN EFFECTIVE DATE AND OTHER PURPOSES.

WHEREAS, the Town has this date held a properly advertised public hearing pursuant to the requirements of 200.065, Florida Statutes, to adopt a tentative millage rate for the 2016-2017 fiscal year; and

WHEREAS, it is the will and desire of the Town Commission that the tentative millage rate be approved and adopted as set forth below.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA:

- <u>Section 1</u>. The whereas clauses are incorporated herein as true and correct and as the legislative findings of the Town Commission.
- <u>Section 2</u>. The Town Commission of the Town of Sewall's Point does hereby adopt its tentative operating millage rate of **2.87** mills to be levied for the General Fund upon all real and tangible personal property located with the boundaries of the above named taxing authority.
- Section 3. The FY 2016-2017 operating millage rate of 2.87 mills is greater than the rolled-back rate of 2.7868 mills by 2.99%.
