



RESOLUTION NO. 897

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, SUPPORTING THE IMPLEMENTATION OF A SEPTIC TO SEWER PROGRAM IN THE TOWN OF SEWALL'S POINT; PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES

WHEREAS, the Town supports the implementation of a septic to sewer conversion program in the Town of Sewall's Point; and

WHEREAS, the Town will request and require financial assistance from State, Federal and/or local agency partners to implement a septic to sewer program; and

WHEREAS, recent soil sampling in the Southern Peninsula indicates enterococci levels above the spectrum of norm; and

WHEREAS, the Connect to Protect program has been completed in North Sewall's Point; and

WHEREAS, there are 652 potential properties to be affected in South Sewall's Point, a septic to sewer program; and

WHEREAS, the Town is surrounded by protected basins; and

WHEREAS, Tidal actions and flooding adversely affect septic tanks, especially those that are not maintained properly; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, AS FOLLOWS:

Section 1. The Town Commission hereby expresses their support of a septic to sewer conversion program in the Town of Sewall's Point. The Town is committed to pursuing funding and

working together with our partners to implement a septic to sewer conversion program in the Town of Sewall's Point.

Section 2. This Resolution shall take effect upon approval by the Town Commission. Commissioner Fender offered the Resolution and moved its adoption. The motion was seconded by Commissioner Tompeck and upon being put to a vote, the vote was:
