Additions are indicated by <u>underlining</u>, deletions are indicated by <u>strikethrough</u>.

**Question No. 1**: Exhibit H "Bid Cost Sheet" is mentioned in the ITB, but it was not included in the ITB.

<u>Answer to No. 1</u>: Exhibit H "Bid Cost Sheet" was inadvertently left out of the ITB. It is attached below and hereby incorporated into the ITB referenced above.

## Town Of Sewall's Point Street Sweeping Exhibit H Bid Schedule September 22, 2021

Complete Items A, B and C which include the completion of all green shaded areas below. The specific breakdown of effective street sweeping dimensions per road per proposed Section of completion are attached, with the consolidated values depicted below in square yards. S. Sewall's Point Road and N. Sewall's Point Road are being widened. After construction is complete, these roadways will be 30 feet wide. State Road A1A is an average of 66 feet wide which includes the asphalt vehicular and bike lanes and the valley curbs. State Road A1A is an arterial road; N. Sewall's Point Road is a minor arterial road; S. Sewall's Point Road, N. River Road and S. River Road are collector roads. All attached road dimensions are are approximations. It is the Contractor's responsibility to verify all conditions before submitting a bid.
