TITANIUM-UDL™ is laid horizontally (parallel) to the eave with the printed side up, and with 3" (76 mm) horizontal laps and 4" (102 mm) vertical laps. The use of a rosin paper slip-sheet is not required underneath metal roofing. TITANIUM-UDL™ must be attached to the roof deck using plastic cap roofing nails having a minimum 1" (25 mm) diameter plastic caps spaced at 12" (30 cm) on center on vertical and horizontal laps, and at 24" (61 cm) along the center of the roll in the field.
