Attached are the monthly financial statements for April 2024. The Town is currently at 58% of the fiscal year completed. The monthly financials are broken out by funds. Although the first column on the Revenue and Expenditure report is titled 2023-24 Amended Budget, this column only reflects a few budget adjustments in the Capital Project Fund. The original budget amount has not been increased nor decreased in the fund.

#### **Balance Sheet**

The two columns shown on the Balance Sheet contains the ending balances for the fiscal year 2023 (first column) and the ending balances as of April 2024. The consolidated cash balance through April 2024 is \$2,815,898.03. The investment account balance as of April 2024 is \$3,917,897.14. The net revenue by fund for the current fiscal year through April is:

#### **Revenue and Expenditure Report**

The columns on the Revenue and Expenditure Statements are the 2024 Adopted Budget, the YTD revenue and expenditures, the variance of actual to budget and the percent of budget used through April 2024.

#### **General Fund**

Total revenue collected in the General Fund through April 2024 was \$3,202,219.52. This amount reflects \$2,782,073.78 million or 98.7% of the budgeted Ad Valorem Taxes. Looking at the total revenues received excluding the Ad Valorem Taxes, revenues came in at 64% of the budgeted amount for the fiscal year.

The amount of the budgeted funds used in the General Fund through April 2024 is \$2,070,110.27. This amount reflects the transfer of property taxes to the Capital Fund of \$344,764 as well as the first, second, & third quarter payments for the fire services contract with the City of Stuart of \$423,923.25. When

removing those two figures for a more accurate representation of day-to-day operational costs and budget status, the Town has used \$1,301,423.02 or 50% of the budgeted expenditures for the fiscal year.

#### **Building Fund**

Total revenue collected in the Building Fund through April 2024 was \$269,067.25, which is 59.6% of the budgeted revenue.

Total expenditures for this fund through April 2024 are at \$246,859.20, 54.7% of the budgeted expenditures, which is similar to funds spent through the same time-period last year.

#### **Capital Fund**

As of April 2024, revenue received was \$930,852.47, of which \$232,020.48 is 70% of budgeted revenues excluding projected grant revenues. Other revenues received in the Capital Fund include a transfer of \$344,764.00 from the General Fund which are restricted for the storm water projects that are projected to start this year and a grant reimbursement from FDEP LPA0217 of \$185,000 for the Commercial Septic to Sewer project that has recently been completed. The Town has also received its first reimbursement of \$166,023 from Martin County for the water main replacement project.

Expenditures as of April 2024 are \$680,721.21 which is 3.8% currently, but will continue to increase as septic to sewer and water main construction bills are paid in the upcoming months.



#### IX. RESOLUTIONS

#### a. Resolution No. 970 - Celebrating Arbor Day & 32<sup>nd</sup> Anniversary as a Tree City

The Town Clerk read the title into the record. Mayor Tompeck called for any public comments, to which there were none. There being no discussion, Vice Mayor **moved** to approve Resolution No. 970. Commissioner Kurzman **seconded** the motion, which **passed unanimously** by roll call vote.

#### X. OLD BUSINESS

#### a. Confirmation of Ballot Language Recommended by the Charter Review

#### Committee – Town Commission Eligibility

The Town Manager stated that the item was brought forward, in order to clarify the eligibility term requirement of one year prior to qualifying to run for commissioner. The Assistant Town Attorney, Susan Garrett, advised that the next step would be to approve the ordinances at first reading that referenced the amendments. She pointed out that after researching the qualification period of a one-year residency, the court opinion held that a one year was reasonable and that there was no evidence that justified two years or more. The Assistant Town Attorney recommended the one-year requirement be enacted.

Commissioner Mayfield was in favor of the one-year requirement. It was the **consensus** of the Commission to move forward with the recommended requirement of a one-year residency to qualify to run for the Town Commission.

#### XI. NEW BUSINESS

#### a. 5-Year Capital Improvement Plan

The Town Manager stated that the CIP included roadway resiliency projects, and that Phase 1 had been completed. He explained that Phase 3 would be put out to bid next month, and that South River Road was on the list for the last two years, as there were drainage issues. The Town Manager pointed out that grants were being pursued in order to cover the estimated cost of \$2.5 million.

The Town Engineer, Joe Capra, stated that the plan included installing a stormwater exfiltration system and underground storage, in order to intercept the overflow of water, as well as the re-sloping of the road. Commissioner Kurzman expressed concern regarding the flow of water onto property owners' homes, as it was not being captured, and alluded to the new construction sites being the culprit that contained massive amounts of fill dirt. He recommended that grates be installed in the easements to contain the excess water.

Mayor Tompeck stated that the CIP did not contain the projects that were previously reviewed with Dr. Kim Delaney and that additional projects were listed that had not been discussed. The Town Manager explained that some of the projects that were listed previously had 10 to 20-year timeframes, and that the five-year projects were prioritized by importance.

Vice Mayor Fender requested the business plan that supported the funding for the multimillion dollar project. The Town Manager advised that the information would be provided during the budget review process.

There being no further discussion, Commissioner Mayfield **moved** to approve the preliminary Capital Improvement Plan. Commissioner Kurzman **seconded** the motion, which **passed unanimously** by roll call vote.

#### XII. DISCUSSION

#### a. 160 S. River Road Flooding – Commissioner Barile

Commissioner Barile stated that he should have been advised that South River Road was included in the CIP, as he had spoken to the Town Engineer regarding the drainage issue. Mayor Tompeck suggested that the funds collected from the CIP millage increase could be used to cover the emergency repairs that were needed. Commissioner Kurzman recommended that the money collected from the permit fees be utilized for the road project.

Commissioner Barile said that there was a catch basin near the property that could be connected to an exfiltration pipe that would extend to a grate, and asked what the cost would be. The Town Engineer responded that it would be less than \$200,000.

There was a **consensus** of the Commission for the Town Manager to work with the Town Engineer to obtain a detailed estimate of the cost and duration to repair the drainage issue, as well as to provide funding sources.

#### **b. Fill Dirt Foundations – New Homes**

Commissioner Barile stated that the two new homes that were being built had a high elevation and that water would run off of them directly onto North Sewall's Point Road. He requested confirmation of the water retention requirements and recommended amending the ordinance. The Building Official stated that the property had a retention area in the front of the property and that a sand berm with rock was installed that worked to stop the water.

#### XIII. COMMISSION AND STAFF CLOSING COMMENTS

#### a. STAFF

The Town Manager stated that he had provided an email to the Commission in reference to the status of the installation of gas lines, as Florida City Gas had sold the company to Chesapeake Utilities and approval was being sought.

#### **b.** COMMISSIONERS

Vice Mayor Fender requested an update in reference to the 10 Oakwood Drive property. The Town Manager responded that upon presenting the fine issue to the Special Magistrate, it was determined that the case needed to go through the proper notice of violation process first.

Vice Mayor Fender inquired as to the status of the ordinance regarding permeable paver bricks, to which the Town Manager responded that the Assistant Town Attorney was working on it and it would be presented for review at the next commission meeting.

Mayor Tompeck queried as to the current situation of the grant writer, to which the Town Manager responded that an RFP was published for a new grant writer.

#### **XV. ADJOURN**

There being no further business, the meeting adjourned at 7:30 p.m.

**Section 7. Charter amendment.** In the event that the majority of electors of the Town voting in the Referendum vote affirmatively to adopt the amendments to Article I, Section 6 of the Town Charter, then said Section shall be amended to read as follows (deletions are shown by overstrike; additions are <u>underlined</u>):

Section 6. - [Same—Filling of vacancies; qualifications.]

In the event a vacancy occurs on the Commission and the unexpired term of the Commissioner is equal to or exceeds six (6) months, the vacancy shall be filled by duly electing a new Commissioner at the next regularly scheduled general election, if such election is scheduled to be held within three (3) months of the time of the vacancy. AN ORDINANCE OF THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA, AMENDING CHAPTER 82, ARTICLE V, SUPPLEMENTARY REGULATIONS, ZONING, SECTION 82-1, DEFINITIONS, TO MODIFY THE DEFINITION OF "IMPERMEABLE AREA" AND ADD A DEFINITION FOR "SEMI-SURFACE" PERVIOUS AND FOR OTHER PURPOSES: PROVIDING FOR SEVERABILITY, THE REPEAL OF ALL CONFLICTING ORDINANCES. CODIFICATION AND AN EFFECTIVE DATE.

WHEREAS, the Town of Sewall's Point, Florida ("Town") is a duly constituted municipality having such power and authority conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and

WHEREAS, the reasonable regulation of impermeable area helps preserve the environment by reducing the risk of flooding and assisting with the management of stormwater runoff; and

WHEREAS, the definition of "Impermeable area" in Section 82-1 of the Sewall's Point Code of Ordinances currently excludes wood decks and pavers set in sand;

WHEREAS, the Town Commission of the Town of Sewall's Point, Florida,

desires to amend the definition of "Impermeable area" in Section 82-1 to eliminate the exemption for wood decks and pavers set in sand; and

WHEREAS, the Town Commission of the Town of Sewall's Point, Florida,

also desires to add to Section 82-1 a definition of the term "Semi-pervious surface".

# NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA THAT:

**Section 1.** The foregoing recitals are hereby fully incorporated herein by reference as legislative findings of the Town Commission of the Town of Sewall's Point.

**Section 2.** The definition of "Impermeable area" in Chapter 82, Zoning, Article I, In General, Section 82-1, Definitions, is hereby amended as follows (deletions are shown by overstrike; additions are <u>underlined</u>):

Impermeable area means the sum total of the ground surface area of a lot not permitting the percolation of water through the pores, interstices, etc., including but not limited to the ground floor area of buildings, structures, pools, patios, porches, driveways, walkways, and other concrete, asphalt or permanent surfacing. This definition shall not pertain to wood decks or pavers set in sand.

**Section 2.** Chapter 82, Zoning, Article I, In General, Section 82-1, Definitions, is hereby amended by adding a definition of the term "Semipervious surface" as follows (deletions are shown by overstrike; additions are <u>underlined</u>):

Semi-pervious surface: A land surface covered with paving products that partially allow the percolation of water at a rate of at least fifty (50) percent based upon manufacturer specifications when correctly installed. Semi-pervious surface shall count toward the calculation of impervious surface at a reduced rate in proportion to the percolation rate of the materials used.

<u>Section 3.</u> <u>Severability.</u> If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions thereof.

<u>Section 4. Repeal of Laws in Conflict.</u> All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

<u>Section 5. Codification.</u> The sections of the ordinance may be made a part of the Town Code of Laws and ordinances and may be re-numbered or relettered to accomplish such, and the word "ordinance" may be changed to "section," "division," or any other appropriate word.

Section 6. Effective Date. This ordinance shall take effect immediately upon adoption.

ARTICLE V, SUPPLEMENTARY REGULATIONS, ZONING, SECTION 82-423, APPLICABILITY OF YARD AND LOT COVERAGE REQUIREMENTS; TENNIS COURTS, SWIMMING POOLS AND OTHER ATHLETIC FACILITIES, TO REMOVE THE OF EXCLUSION ATHLETIC FACILITIES FROM THE CALCULATION OF LOT COVERAGE, AND FOR OTHER PURPOSES; PROVIDING FOR SEVERABILITY, THE REPEAL OF ALL CONFLICTING ORDINANCES, CODIFICATION AND AN EFFECTIVE DATE.

WHEREAS, the Town of Sewall's Point, Florida ("Town") is a duly constituted municipality having such power and authority conferred upon it by the Florida Constitution and Chapter 166, Florida Statutes; and

WHEREAS, the reasonable regulation of lot coverage helps preserve the

environment by maintaining a balance between open and built spaces, reducing

the risk of flooding and supporting the management of stormwater runoff; and

WHEREAS, Section 82-423(a) of the Sewall's Point Code of Ordinances currently provides that tennis courts and other athletic facilities shall not considered a part of the building in the determination of percentage of lot coverage;

**WHEREAS,** the Town Commission of the Town of Sewall's Point, Florida, desires to amend Section 82-423(a) to eliminate this exemption such that tennis

courts and other athletic facilities will be included in the calculation of lot coverage..

# NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA THAT:

<u>Section 1.</u> The foregoing recitals are hereby fully incorporated herein by reference as legislative findings of the Town Commission of the Town of Sewall's Point.

**Section 2.** Chapter 82, Zoning, Article V, Supplementary Regulations, Section 82-423(a), *Applicability of yard and lot coverage requirements; tennis courts, swimming pools and other athletic facilities*, is hereby amended as follows (deletions are shown by overstrike; additions are <u>underlined</u>):

(a) Applicability of requirements to athletic facilities. Tennis courts or other athletic facilities, such as but not limited to swimming pools, pool structures, poolside aprons, and terraces, shall not be considered a part of the building in the determination of yard sizes or percentage of lot coverage, but, shall be included in the calculation of lot coverage and shall be subject to building setback line regulations.

<u>Section 3.</u> <u>Severability.</u> If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions thereof. Section 4. Repeal of Laws in Conflict. All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.
