INVITATION TO BID

SOUTH SEWALL'S POINT ROAD – PHASE 3

The Town is proposing the raising of South Sewall's Point Road from Pineapple Lane north to Ridgeland Drive including additional work in (a) South River Road at Marguerita intersection and (b) 1 Mandalay Road retention area. These improvements will include: roadway improvements, stormwater improvements that include two separate exfiltration systems, sheet pile weirs and modifications of a baffle box. The base bid will include roadway, stormwater and utility adjustment items. The alternative bid schedule will include private lot drainage improvements.

A pre-proposal meeting is scheduled for 2:00 P.M., local time, at Town Hall located at 1 South Sewall's Point Road, Sewall's Point, Florida 34996 on June 27, 2024.

The resulting contract shall be awarded to the lowest, responsive and responsible bidder whose total base and alternative bids the requirements and criteria set forth in this ITB and whose award will be in the best interest of and most advantageous to the Town of Sewall's Point, taking into consideration, among other things, Base Bid amount, the financial responsibility of the bidder, quality of materials, personnel and equipment resources, proven skill and experience, abilities to timely perform the contract, previous satisfactory performance and such other abilities of the bidder that the Town, in its sole discretion, determines will enable it to perform effectively and efficiently the contract being bid upon.
