

ORDINANCE NO. 4

(Electrical Code)

AN EMERGENCY ORDINANCE BY THE TOWN OF SEWALL'S POINT, A FLORIDA MUNICIPALITY, FIXING AND PROVIDING REGULATIONS FOR ELECTRICAL CONSTRUCTION, REPAIR, REMODELING AND ALTERATION OF ELECTRICAL WIRING AND ELECTRICAL WORK IN ALL BUILDINGS WITHIN THE TOWN OF SEWALL'S POINT, FLORIDA; FIXING AND PROVIDING THE ELECTRICAL CONSTRUCTION REGULATIONS FOR ALL BUILDINGS WITHIN THE TOWN OF SEWALL'S POINT, FLORIDA; REQUIRING THE OBTAINING OF PERMITS THEREFOR AND FIXING THE FEES THEREFOR; PROVIDING AND ESTABLISHING AN ELECTRICAL CODE FOR THE TOWN OF SEWALL'S POINT, FLORIDA, AND FOR OTHER PURPOSES; PROHIBITING VIOLATIONS OF THIS ORDINANCE AND PROVIDING PENALTIES FOR SUCH VIOLATIONS.

BE IT ORDAINED BY THE MAYOR AND THE TOWN COMMISSION OF THE TOWN OF SEWALL'S POINT, FLORIDA:

Section 1. The Town of Sewall's Point, Florida does hereby adopt as an Electrical Code for the said Town the attached Edition of the National Electrical Code as hereby amended, which is herewith made a part hereof as fully as if herewith completely incorporated.

Section 2. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

Section 3. This ordinance shall take effect immediately upon its passage as required by laws.

Section 4. This ordinance is hereby declared to be an emergency measure upon the ground of grave emergency and urgent need for the preservation of public peace, health, safety and welfare, and shall take effect immediately upon its passage and adoption.
