

ORDINANCE NO. 20

AN EMERGENCY ORDINANCE MAKING APPROPRIATION FOR THE EXPENSE OF CONDUCTING EACH DEPARTMENT AND DIVISION OF GOVERNMENT OF THE TOWN OF SEWALLS POINT IN MARTIN COUNTY, FLORIDA, AND THE DEBTS OF SAID TOWN FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 1959 AND ENDING SEPTEMBER 30, 1960.

WHEREAS, an emergency exists for the passage of said Ordinance in that the same is necessary for the immediate preservation of the public peace, property, health and safety of the people of the town of Sewalls Point, Florida, and,

WHEREAS, pursuant to law the Department of Finance has submitted its annual report and estimate to the Town Commission setting forth an estimate of expenditures and revenues for the operation of said Town for the fiscal year beginning October 1, 1959 and ending September 30, 1960.

THEREFORE, BE IT ENACTED BY THE PEOPLE OF THE TOWN
OF SEWALLS POINT, FLORIDA:

1. That the following amounts as shown under their respective headings or designations in this section are hereby approved for the expense of conducting each department and division of the Government of the Town of Sewalls Point, including the enterprises thereof and for the debts of said Town for the fiscal year beginning October 1, 1959 and ending September 30, 1960.
