AN ORDINANCE ADOPTING MODEL TRAFFIC ORDINANCE FOR MUNICIPALITIES, BEING CHAPTER 186, FLORIDA STATUTES, 1963, BY THE TOWN OF SEWALL'S POINT, FLORIDA.

BE IT ENACTED BY THE PEOPLE OF THE TOWN OF SEWALL'S POINT, FLORIDA:

Section I. All of the provisions and requirements of Chapter 186, Florida Statutes, <sup>1963</sup> 1963, being the Model Traffic Ordinance for Municipalities for the regulation of traffic on highways, roads and streets, are hereby adopted as and made part of the ordinances, laws and regulations governing the flow of traffic over the streets and roads of the Town of Sewall's Point, Florida, as if the same had been duly set out herein.

Section II. All ordinances and parts of ordinances in conflict herewith be, and the same are hereby repealed.

Section III. This ordinance shall take effect upon its due passage according to law.

PASSED first reading at meeting of the Town Commission held on the 13 day of October, 1965.

PASSED second reading and became law by the meeting of the Town Commissioners held on the 10 day of November, 1965.
