

ODINANCE NO. 52

AN EMERGENCY ORDINANCE OF THE TOWN OF SEWALL'S POINT, FLORIDA, TO PROMOTE THE HEALTH, SAFETY, MORALS AND GENERAL WELFARE OF THE INHABITANTS OF THE TOWN OF SEWALL'S POINT, FLORIDA, BY PROVIDING FOR THE APPOINTMENT OF A TOWN POLICEMAN AND FOR FIXING OF HIS SALARY.

BE IT ENACTED BY THE PEOPLE OF THE TOWN OF SEWALL'S POINT, FLORIDA:

Section 1. In accordance with the provisions of Article IV, Section 3, of the Charter of the Town of Sewall's Point, Florida, Charles A. Duryea is hereby appointed Town Policeman of the Town of Sewall's Point, Florida.

Section 2. The above appointed policeman shall serve without salary but shall be remunerated for his services, while on duty as Town Policeman, at the rate of eleven-cents (11¢) per mile.

Section 3. The duties of the Policeman are those prescribed by the Charter of the Town of Sewall's Point and the General Laws of the State of Florida.

Section 4. An emergency exists for the passage of this ordinance in that the same is necessary for the immediate preservation of public peace, property, health and safety of the people of the Town of Sewall's Point, Florida

Section 5. This ordinance shall take effect immediately upon its passage as required by law.

PASSED and became a law at the regular meeting of the Town Commissioners held on the 10th day of April, 1968.
