

AN ORDINANCE PROVIDING FOR THE ADOPTION OF CHAPTERS 186, 317, AND 322.261, FLORIDA STATUTES, 1967, WITHIN THE TOWN OF SEWALL'S POINT BY REFERENCE TO STATE STATUTES AND PROVIDING CERTAIN EXCEPTIONS THERETO.

WHEREAS, the Town Commission is interested in protecting the citizens of the Town of Sewall's Point, and preserving the peace and dignity due them as citizens of said Town, and

WHEREAS, it is their judgment the best protection would be to preserve to them the same protection as granted under state law.

NOW, THEREFORE, BE IT ENACTED BY THE PEOPLE OF THE TOWN OF SEWALL'S POINT:

Section 1. There is hereby adopted by reference as fully and to the same effect as if set out at length herein Chapters 186, 317, and 322.261, Florida Statutes, 1967, a certified copy of which is on file in the office of the City Clerk.

Section 2. There is hereby excepted from the provisions adopted by Section 1 of this Ordinance any reference to trial by jury. There is further excepted from the provisions adopted by Section 1 of this Ordinance such of the regulations as by their nature could have no application within a City.

Section 3. Where any provisions of Chapters adopted by Section 1 of this ordinance shall conflict with past or future ordinances of the City Commission of this town the ordinances of Sewalls Point shall control.

This Ordinance shall take effect immediately upon its passage as required by law.

PASSED first reading at meeting of Town Commission held on the 13 day of November, 1968.

PASSED second reading and became a law at the regular meeting of the Town Commission held on the 11 day of December, 1968.

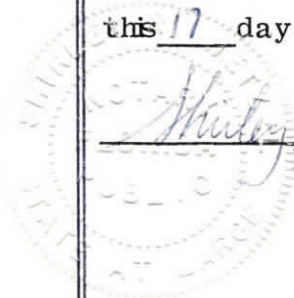
