

ORDINANCE NO. 60

AN ORDINANCE OF THE TOWN OF SEWALL'S POINT, FLORIDA, PROVIDING FOR THE ADOPTION OF CHAPTERS 186, 317, 322 and 261, FLORIDA STATUTES 1967 AS AMENDED IN 1969 LEGISLATURE WITHIN THE TOWN OF SEWALL'S POINT BY REFERENCE TO STATE STATUTES AND PROVIDING CERTAIN EXCEPTIONS THERETO.

WHEREAS, the Town Commission is interested in protecting the citizens of the Town of Sewall's Point, and preserving the peace and dignity due them as citizens of said Town, and

WHEREAS, it is their judgment that the best protection would be to preserve to them the same protection as granted under state law.

NOW, THEREFORE, BE IT ENACTED BY THE PEOPLE OF THE TOWN OF SEWALL'S POINT, FLORIDA:

Section 1. There is hereby adopted by reference as fully and to the same effect as if set out in length Chapters 186, 317, 322 and 261, Florida Statutes 1967, as amended in 1969 Legislature, a certified copy a certified copy of which is on file in the office of the Town Clerk.

Section 2. There is hereby excepted from the provisions adopted by Section 1 of this Ordinance any reference to trial by jury. There is further excepted from the provisions adopted by Section 1 of this Ordinance such of the regulations as by their nature could have no application within a Town.

Section 3. There is hereby adopted by reference as fully and to the same effect as if set out in full herein any provisions of Florida Statutes 1967, together with any amendments made by 1969 Florida Legislature regarding misdemeanors.

Section 4. Where any provisions of Chapters adopted by Section 1 of this Ordinance shall conflict with past or future ordinances of the

Town Commission of this Town the Ordinances of Sewall's Point shall control.

Section 5. This Ordinance shall take effect immediately upon its passage as required by law.

PASSED first reading of Town Commission held on the 10 day of September, 1969.

PASSED second reading and became a law at the regular meeting of the Town Commission held on the 8 day of October, 1969.
